

FAET Spring Conference March 4-7, 2010
Carnival Ship Sensation, Port Canaveral to Nassau, Bahamas
"Nuts and Bolts Keeps our Ship Afloat"

It's time to plan for the spring conference of FAET. The 2010 conference will once again take to the high seas. Due to the Cruise versus Hotel difference, **YOU need to make the commitment** now for next year's conference. Group space on a cruise ship has more stringent rules regarding space maintenance, which requires the need for you to make a deposit to hold your cabin space. The following is Key information you need.

You have not missed the deposit date. We tried to have as many of you as possible send your deposit early so that Carnival will maintain our group space as a viable group sailing. They would like ALL the deposits, NOW. However, we know it is difficult to plan this far out. So we are and still will be accepting the deposits. But the longer you wait, there is a possibility that we may lose some of the group reserved space. If you book at a later date, there may be a higher price per stateroom.

1. Cost **per person**:

2. Deposits required:

- 1) \$25 per person to hold space which will allow the ship to choose your cabin either at the front or the back portion of the ship.
- 2) \$100 per person to hold space which allows us to choose you a cabin midship. These will go fast.
- 3) First deposit needed **NOW**. Final payment will be due December 31, 2009.
- 4) Each person or family needs to complete the application form. Again a reminder, the name on the application **MUST** match the name on the passport, or you will be denied boarding.

3. *Fuel surcharge: The cruise line may add a fuel surcharge of \$9/day to the cost of the cruise if the cost of oil increases. Everyone must pay this. If at the time of sailing the cost of oil has dropped based on CCL terms and conditions, the charge will be refunded by Carnival.

4. Gratuities: Tips will be collected up front. This is \$10/day per person. This way you have nothing to worry about at the end of the cruise and we may all sit as a group at meals. This will be added at final payment.

5. As a group, we will have 1st seating for dinner at 6:30 PM. You will be able to move about within our group during our three nights at sea.

6. PASSPORTS will be required for EVERYONE. So get your application submitted. It takes 2-4 months to process. Don't wait to the last minute to submit your application, you may miss the ship sailing. If anyone in your group has a green card, they **MUST** bring it with them to board the ship.

7. Insurance: This is **highly** recommended. You will need to sign up for this at the time of initial deposit. The insurance will give you peace of mind. If for any reason you need to cancel the trip, you will receive your money back. OR, if you have a mishap during the cruise, it will pay for your emergent care. Your personal health insurance usually DOES NOT pay out of the country. Check yes or no on application form.

For those of you who desire the cruise insurance, we are working to get a good price for you and will contact you by e-mail. For those who decline the insurance, we will need your signature that it was offered and

declined. If you check the appropriate boxes on the registration form, that would be adequate. If we do not receive the notice of “no insurance”, we will not release documents until we have it.

8. Plenty of space has been reserved. If you have friends or other family members who would like a brief vacation from life’s chaos, PLEASE share this information with them. Contact us for additional fliers if you want to post it for the nurses at your facility.

9. As the deadlines approach we will e-mail everyone with a reminder. Please note that these second and/or final payments are specific from Carnival and are not allowed to be extended as we may do with the initial payment. If you miss these dates, your cruise will be cancelled by Carnival.
